### **59. Declarations of Interest**

There were no items on the agenda that resulted in Members declaring either a personal or a prejudicial interest.

### **60. Minutes of the Last Meeting of the Parish Council**

The minutes of the last meeting of the Parish Council held on Wednesday 19<sup>th</sup> November 2003, having been circulated, were confirmed a correct record and signed by the Chairman.

### **61. Matters Arising on the Minutes**

- i. The Chairman had completed and returned the questionnaire on the Parish Council Survey.
- ii. The Vice Chairman had completed and returned the survey on the First Annual Review of the West Berkshire Community Plan.

### **62. Planning Committee**

The minutes of the meeting of the Planning Committee held on 30<sup>th</sup> December 2003 were received and the proceedings adopted.

The SPISE Winter Newsletter was received and tabled.

It was agreed that the views of Dave Pearson, an officer in the West Berkshire District Council Planning Department, be sought in regard to two sites that may be subject to future certificates of lawfulness.

The Panel Report following the Examination into the Berkshire Structure Plan had now been published, and was available in hard copy format.

**64. Highways, Footpaths and Traffic Matters**

There had not been any follow up from the information received at the last meeting in regard to the work requested in the vicinity of Sulham Hill.

No additional issues were raised.

**65. Environment Agency**

District Councillor John Chapman had sent the Parish Council a copy of the Purley Flooding Report which had been commissioned following the problems encountered during the flooding in January 2003.

It was observed that the water in the Pang was at a relatively low level notwithstanding the recent heavy rain. This may have been due to the work undertaken by the Environment Agency, or the fact that the water had not yet returned to the desired levels in the underground aquifers.

**66. Crime and Disorder**

A new non emergency number had been launched to make it easier for the public to contact the Thames Valley Police. The new number, **0845 8 505 505**, should put the caller through to one of two Police Enquiry Centres where an experienced operator should be able to route the call to, hopefully, the correct location.

**67. West Berkshire District Council – Parish Council Survey**

It was agreed not to complete the questionnaire on the subject of Area Forums.

**68. Financial Matters**

The audit of the Annual Return for the year ended 31<sup>st</sup> March 2003 had been completed and the appropriate notice displayed on the notice boards in Tidmarsh and Sulham.

**73. Royal Berkshire Fire Authority Risk Management Plan**

The role of the Fire Service was changing, and, for the first time, the fire and rescue service was to be formally recognised as a provider of a wide range of protection services to the community. An Integrated Risk Management Plan entitled "A Safer Berkshire" had been produced and comments were invited.

**74. Fireworks Act 2003**

Martin Salter, MP, had, after a lengthy delay and several reminders, replied to the letter written during January 2003, requesting his support in achieving a reduction in the noise and availability of fireworks because of the threat they pose to the well being of the elderly and animals.

The Fireworks Act 2003 will enable the Government to apply restrictions to the sale and use of fireworks. Coupled with the Night Noise Offence within the Noise Act 1996 it may result in a reduction in the indiscriminate use of very loud fireworks used throughout the year.
