## **84. Minutes from last meeting**

Parish council resolved to ask that an officer from West Berkshire council attend the next meeting to provide more clarity on what the S106 money can be spent on and what defines an 'open space'.

Councillor Broun provided an update on the Millennium Green Trustee meeting. They have received estimates for improvement projects including replacement fencing, a bandstand and play area. A request was made to purchase mowing equipment as the grass is currently cut with a parishioners own mowing equipment. Councillor Broun confirmed that the Millennium Green Trustees do not have any funds and rely on the parish council precept to pay for maintenance and improvements.
